Greetings to all Marlborough Justices of the Peace Tēnā koutou katoa

Keeping your information current:

Please remember that if you change your address, your email address, or your phone number (including dropping your landline) you need to complete two actions:

You need to let Ian Cameron know, so that our local Association records can be updated.

He cannot update the website for you, so you also need to go to The Royal Federation website www.ipfed.org.nz and log on. Your username is your last name and JP number (e.g., smith 11039) and the password is one of your choice. If you have forgotten your password, just click on the hyperlink (forgot your password) and a temporary one will be emailed to you.

Go to **Your Profile** to update details or availability. Availability is in two parts - right under phone number information, you will find "Not available" where you can enter the dates you are going to be away or for the time through sickness a JP"., etc, it is not appropriate to have clients call. Your name will automatically be removed from "Find a JP" for that time.

Below "address details" is a box called "availability". A drop-down menu gives you a choice of times you are available, and the one you select will appear on "Find a JP".

Your profile is also the place you go to, to update the last KU2D session you attended, to keep your accreditation current. You will find this box called "Education session" and it is right under "Not available". You need to use the calendar on the system for it to work, rather than typing in the date.

Remember to go all the way to the bottom to press save.

Client identification requirements:

This interesting piece appeared in the Rotorua and District Newsletter (June 2021).

ASK JULIE

Those of you who attended the last KU2D session may remember that we had a discussion about client identification requirements, in particular regard to Affidavits.

The discussion centred around a client who had appeared before a JP and urgently needed her affidavit taken because she had only a short amount of time to get it to the court for inclusion in a pending case. The client had no form of photo ID on her, and no way to get any in time.

The JP in question felt that she needed to see some form of photo ID, and at the time I totally agreed. However, on reflection I admit that I was wrong. There is no legal requirement to see photo ID for a client who presents with an affidavit, a statutory declaration or for witnessing of a signature. Of course, sighting the ID would be **best practice**, and the best way to be satisfied of the person's identity. However, if no ID is available, the JP could ask reasonable, non-intrusive questions , such as full name, address or occupation to satisfy themselves that the person sitting before them is who they say they are. It isn't a legal requirement and we can't refuse to administer a person's document because they don't have photo ID. Remember, we only need to be <u>reasonably satisfied</u> of our clients identity.

Most importantly, "Identifying your client" must not be confused with the task of "Verifying the identity of a client" as in the case of AML-CFT or specific agency requirements. Please check sections 3.3 and 2.3.1 in your new manual for clarity in these cases.

Presentation of Long Service Certificates:

At the commencement of the KU2D session on 24th April, Life Members Gavin Kerr and Roger Rose were called upon to present Certificates of Appreciation signed by the Secretary for Justice to four of our Justices who have completed over 30 years' service. At the same time, Gavin presented Brenda Carr with her JP Retired certificate and medallion. Brenda was appointed as a Justice of the Peace in September 1980.
